**Depth Study A: Manifest Destiny and Early Expansion 1830–1880**

Read the background information and then answer all the questions. Use your knowledge of the topic to help you interpret and evaluate the sources, as appropriate.

**Background Information**

While the attractions of a new life caused many thousands to journey west, the new settlers soon found themselves facing many challenges.

What can you learn from this source about the problems that faced farmers who settled in the West? Explain your answer using details from the source **and** your knowledge. [6]

**2** Study Source B.

How useful is this source to a historian studying the health problems which faced homesteaders? Explain your answer using details from the source **and** your knowledge. [7]

**3** Study Source C.

How reliable is this source as evidence of the threat that insects posed to farmers in the West? Explain your answer using details from the source **and** your knowledge. [7]

**4** Study Sources D and E.

Why do these sources differ in their views of law and order in Montana? Explain your answer using details from the sources **and** your knowledge. [10]

**5** Study **all** the sources.

“The establishment of law and order was the biggest concern of settlers in the West.” To what extent do you agree? Explain your answer using details from Sources A–G **and** your knowledge. [15]

**Depth Study B: The Women's Suffrage Movement 1866–1920**

Read the background information and then answer all the questions. Use your knowledge of the topic to help you interpret and evaluate the sources, as appropriate.

**Background Information**

After 1866, women continued to demand the vote. However, not everyone was in favor of women being granted the vote, and this resulted in the development of an anti-suffrage movement.

**6** Study Source A.

What is the message of this source? Explain your answer using details from the source **and** your knowledge. [6]

**7** Study Source B.

How useful is this source to a historian studying the arguments used against women getting the vote? Explain your answer using details from the source **and** your knowledge. [7]

**8** Study Source C.

How accurately does this source portray views on women's suffrage in the United States? Explain your answer using details from the source **and** your knowledge. [7]

**9** Study Sources D and E.

Why do these sources differ in their views about the role of women? Explain your answer using details from the sources **and** your knowledge. [10]

**10** Study **all** the sources.

"More women opposed the campaign for women's suffrage than supported it." To what extent do you agree? Explain your answer using details from Sources A–G **and** your knowledge. [15]

**Depth Study C: The United States and the World 1880–1917**

Read the background information and then answer all the questions. Use your knowledge of the topic to help you interpret and evaluate the sources, as appropriate.

**Background Information**

The Monroe Doctrine of 1823 which spelled out the importance of not getting involved in the affairs of Europe still held considerable influence in the early twentieth century. From 1914 to 1917, there were discussions about whether the United States should enter the war.

**11 Study Source A.**

What can you learn from this source about the reaction in the United States to the sinking of the Lusitania? Explain your answer using details from the source **and** your knowledge. [6]

**12 Study Source B.**

How useful is this source to a historian studying the reasons why the United States entered the war? Explain your answer using details from the source **and** your knowledge. [7]

**13 Study Source C.**

How reliable is this source as evidence of the possible impact on the United States of entering the war in 1917? Explain your answer using details from the source **and** your knowledge. [7]

**14 Study Sources D and E.**

Why do these sources differ in their accounts about whether the United States should be involved in the war? Explain your answer using details from the sources **and** your knowledge. [10]

**15 Study all the sources.**

“Unrestricted submarine warfare waged by Germany was the main reason that the United States entered the war in 1917.” To what extent do you agree? Explain your answer using details from Sources A–G **and** your knowledge. [15]

**Depth Study D: American Society and Popular Culture c.1920–1970**

Read the background information and then answer all the questions. Use your knowledge of the topic to help you interpret and evaluate the sources, as appropriate.

**Background Information**

The 1950s was a time of change in the United States. The country had recovered from the Second World War, and for some it resulted in a more affluent lifestyle with new fashion, music and entertainment. Religion also became more popular. However, this new lifestyle was not welcomed by all, especially by younger people, some of whom rebelled against traditional values.

What is the message of this source? Explain your answer using details from the source **and** your knowledge. [6]

**17 Study Source B.**

How useful is this source to a historian studying the religious revival of the 1950s? Explain your answer using details from the source **and** your knowledge. [7]

**18 Study Source C.**

How reliable is this source as evidence of the impact of McCarthyism? Explain your answer using details from the source **and** your knowledge. [7]

**19 Study Sources D and E.**

Why do these sources disagree in their views of the threat facing the United States in the 1950s? Explain your answer using details from the sources **and** your knowledge. [10]

**20 Study all the sources.**

“The 1950s was a decade of conformity and contentment.” To what extent do you agree? Explain your answer using details from Sources A–G **and** your knowledge. [15]
