

How reliable is this source as evidence of the workings of the legal system in the West? Explain your answer using details from the source **and** your knowledge. [7]

4 Study Sources D and E.

Why do these sources differ in their view of the outlaw Billy the Kid? Explain your answer using details from the sources **and** your knowledge. [10]

5 Study **all** the sources.

“Vigilante groups played the main role in enforcing law and order in the West.” To what extent do you agree? Explain your answer using details from **all** the sources **and** your knowledge. [15]

Depth Study B: The Women's Suffrage Movement 1866–1920

Read the background information and then answer all the questions. Use your knowledge of the topic to help you interpret and evaluate the sources, as appropriate.

Background information

During the first decade of the twentieth century the demand for female suffrage gathered pace and grew in strength. Not all women, however, welcomed the call for an extension of the franchise.

What can you learn from this source about the attitudes of the anti-suffragists towards the suffragists? Explain your answer using details from the source **and** your knowledge. [6]

7 Study Source B.

How useful is this source to a historian studying the arguments used by anti-suffragists in their campaign to oppose the vote? Explain your answer using details from the source **and** your knowledge. [7]

8 Study Source C.

How reliable is this source as evidence of anti-suffragist opposition to the Nineteenth Amendment? Explain your answer using details from the source **and** your knowledge. [7]

9 Study Sources D and E.

Why do these sources differ in their accounts about the level of support for the suffrage cause? Explain your answer using details from the sources **and** your knowledge. [10]

10 Study all the sources.

“During the early twentieth century the campaign for female suffrage attracted increasing support from women across America.” To what extent do you agree? Explain your answer using details from **all** the sources **and** your knowledge. [15]

Depth Study C: The United States and the World 1880–1917

Read the background information and then answer all the questions. Use your knowledge of the topic to help you interpret and evaluate the sources, as appropriate.

Background information

In the years immediately before 1917 there was great debate within America about the future direction of US foreign policy. The key debate was over whether to intervene in the war in Europe.

12 Study Source B.

How useful is this source to a historian studying the role of the US in world affairs before the First World War? Explain your answer using details from the source **and** your knowledge. [7]

13 Study Source C.

How reliable is this source as evidence of the reaction within the United States to the news of the sinking of the *Lusitania* in May 1915? Explain your answer using details from the source **and** your knowledge. [7]

14 Study Sources D and E.

Why do these sources differ in their view of how the United States should respond to the sinking of the *Lusitania*? Explain your answer using details from the sources **and** your knowledge. [10]

15 Study all the sources.

“Before 1917 most Americans wanted the United States to play a peaceful role in international affairs.” To what extent do you agree? Explain your answer using details from **all** the sources **and** your knowledge. [15]
