**Generic Marking Principles**

These general marking principles must be applied by all examiners when marking candidate answers. They should be applied alongside the specific content of the mark scheme or generic level descriptors for a question. Each question paper and mark scheme will also comply with these marking principles.

**GENERIC MARKING PRINCIPLE 1:**

Marks must be awarded in line with:

- the specific content of the mark scheme or the generic level descriptors for the question
- the specific skills defined in the mark scheme or in the generic level descriptors for the question
- the standard of response required by a candidate as exemplified by the standardisation scripts.

**GENERIC MARKING PRINCIPLE 2:**

Marks awarded are always **whole marks** (not half marks, or other fractions).

**GENERIC MARKING PRINCIPLE 3:**

Marks must be awarded **positively**:

- marks are awarded for correct/valid answers, as defined in the mark scheme. However, credit is given for valid answers which go beyond the scope of the syllabus and mark scheme, referring to your Team Leader as appropriate
- marks are awarded when candidates clearly demonstrate what they know and can do
- marks are not deducted for errors
- marks are not deducted for omissions
- answers should only be judged on the quality of spelling, punctuation and grammar when these features are specifically assessed by the question as indicated by the mark scheme. The meaning, however, should be unambiguous.

**GENERIC MARKING PRINCIPLE 4:**

Rules must be applied consistently, e.g. in situations where candidates have not followed instructions or in the application of generic level descriptors.

**GENERIC MARKING PRINCIPLE 5:**

Marks should be awarded using the full range of marks defined in the mark scheme for the question (however; the use of the full mark range may be limited according to the quality of the candidate responses seen).

**GENERIC MARKING PRINCIPLE 6:**

Marks awarded are based solely on the requirements as defined in the mark scheme. Marks should not be awarded with grade thresholds or grade descriptors in mind.

2(c)	<p><b>The work of Shah Waliullah was the main factor contributing to the spread of Islam between 1700 and 1850.’ How far do you agree with this statement? Explain your answer.</b></p> <p>Target: AO1, AO2 Mark according to the level of response descriptors in Table 2.</p> <p>Indicative content</p> <p><b>May agree</b> that the work of Shah Waliullah was the main factor contributing to the spread of Islam in the subcontinent between 1700 and 1850 because:</p> <ul style="list-style-type: none"> <li>• Shah Waliullah wanted to stop the decline of Islam</li> <li>• he promoted Islam through his writings and education</li> <li>• he translated the Quran into Persian</li> <li>• he tried to unite different Muslim sects</li> </ul> <p><b>counter-arguments</b> might include:</p> <ul style="list-style-type: none"> <li>• the founding of the Jihad Movement by Syed Ahmad Barelvi to help unite Muslims</li> <li>• he also created an army (the Mujahideen - fighters for the faith)</li> <li>• the establishment of the Faraizi Movement by Haji Shariatullah</li> <li>• he wanted all Muslims to give up non-Muslim practices</li> </ul> <p>Other relevant responses should also be credited.</p>	14

Additional mark for supporting detail.</p> <p>Indicative content</p> <ul style="list-style-type: none"> <li>• Allama Iqbal chaired a meeting of the Muslim League in Allahabad</li> <li>• in his presidential address [1] he called for all Muslims to work towards achieving a separate homeland [1]</li> <li>• he argued that Islam united Muslims into one nation [1] and there could be no peace unless they were recognised as such [1]</li> <li>• he wanted some areas to be amalgamated into a separate state (Punjab, NWFP and Balochistan) (any one named [1])</li> </ul> <p>Other relevant responses should also be credited.</p>	4

Additional mark for supporting detail.</p> <p>Indicative content</p> <ul style="list-style-type: none"> <li>• an agreement signed in July 1972 [1] between Bhutto [1] and Gandhi [1]</li> <li>• India agreed to return imprisoned soldiers [1]</li> <li>• Both countries promised to discuss the Kashmir issue [1]</li> <li>• and not with organisations such as the United Nations [1]</li> </ul> <p>Other relevant responses should also be credited.</p>	<b>4</b>
4(b)	<p><b>Explain why Congress and the Muslim League opposed the Cripps Mission of 1942.</b></p> <p>Target: AO1, AO2 Mark according to the level of response descriptors in Table 1.</p> <p>Indicative content</p> <ul style="list-style-type: none"> <li>• the Muslim League wanted reference to the establishment of Pakistan</li> <li>• Congress wanted immediate control over India</li> <li>• Congress was unsure that the British would deliver the proposals in the plan</li> <li>• Congress wanted to exploit Britain's weak position at this time</li> </ul> <p>Other relevant responses should also be credited.</p>	<b>7</b>

Explain your answer.</b></p> <p>Target: AO1, AO2 Mark according to the level of response descriptors in Table 2.</p> <p><b>May agree</b> that agricultural policies were the most effective of Ayub Khan’s domestic policies:</p> <ul style="list-style-type: none"> <li>• land was redistributed</li> <li>• tenant farmers were introduced</li> <li>• farmers were given loans</li> <li>• farming productivity increased</li> <li>• irrigation schemes were introduced</li> <li>• farming mechanisation was introduced</li> </ul> <p><b>Counter-arguments</b> might include:</p> <ul style="list-style-type: none"> <li>• an oil refinery was built in Karachi</li> <li>• a Mineral Development Corporation was set up</li> <li>• an export bonus scheme was started</li> <li>• economic growth increased</li> <li>• the price of milk was fixed</li> <li>• new houses were built</li> <li>• new schools and a new curriculum were introduced</li> <li>• refugees were found new homes</li> <li>• a family planning programme was established</li> <li>• medical facilities were improved</li> <li>• a new capital was built at Islamabad</li> <li>• a Basic Democracy Scheme was implemented</li> </ul> <p>Other relevant responses should also be credited.</p>	14

Additional mark for supporting detail.</p> <p>Indicative content</p> <ul style="list-style-type: none"> <li>• Zia-ul-Haq [1] chose him as Prime Minister [1] in 1985 [1]</li> <li>• Muhammad Khan Junejo worked to develop the new Muslim League party</li> <li>• he called an all-Party Conference [1] in 1988 [1] to discuss the Afghan situation [1]</li> <li>• he announced an inquiry into an explosion at the army weapons dump/ Ojhri Camp [1] in 1988 [1] promising justice [1]</li> <li>• he was dismissed from office [1] by Zia-ul-Haq [1] on 29 May 1988 [1]</li> </ul> <p>Other relevant responses should also be credited.</p>	<b>4</b>
5(b)	<p><b>Explain why there were changes of government between 1951 and 1958.</b></p> <p>Target: AO1, AO2 Mark according to the level of response descriptors in Table 1.</p> <p>Indicative content</p> <ul style="list-style-type: none"> <li>• Muhammad Ali Jinnah and Liaquat Ali Khan had died</li> <li>• the remaining politicians were inexperienced</li> <li>• In 1953 there was a severe drought causing food shortages</li> <li>• there was some discontent amongst the people who were suffering hardship leading to riots</li> <li>• East Pakistan had faced severe floods causing food shortages in 1955</li> </ul> <p>Other relevant responses should also be credited.</p>	<b>7</b>

Explain your answer.</p> <p>Target: AO1, AO2 Mark according to the level of response descriptors in Table 2.</p> <p>Indicative content</p> <p><b>May agree</b> that Pakistan has had good relations with the United States of America since 1947:</p> <ul style="list-style-type: none"> <li>• Pakistan signed the Mutual Defence Assistance Agreement in 1954</li> <li>• Pakistan joined SEATO in 1955</li> <li>• Ayub Khan allowed USA to build air bases in Pakistan</li> <li>• USA gave aid packages of \$1.6 billion spread over five years in 1981 and \$4.2 billion in 1986</li> <li>• President Clinton restored sales of aircraft to Pakistan in 1993</li> <li>• First Lady of the USA visited Pakistan in 1996</li> <li>• Benazir Bhutto visited USA in 1996</li> <li>• USA reimbursed Pakistan for the F-16 payments and provided military equipment worth \$388 million in 1996</li> </ul> <p><b>counter-arguments</b> might include:</p> <ul style="list-style-type: none"> <li>• USA provided military equipment to India during its war with China in 1962</li> <li>• Pakistan turned away from USA to China for friendship in 1962</li> <li>• USA placed an arms embargo on India and Pakistan in 1965</li> <li>• USA aid was suspended in 1977 and 1979 during Zia-ul-Haq's rule</li> <li>• at the end of the Afghan conflict USA would not declare Pakistan nuclear free and blocked aid</li> <li>• In 1992 the USA placed economic sanctions on Pakistan</li> <li>• USA objected to Pakistan's nuclear tests in 1998</li> </ul> <p>Other relevant responses should also be credited.</p>	14
